Booking Conditions

1. BOOKING CONFIRMATION

- a) All bookings are made with adidas International Training Program. (the Company), whose main business address in the USA is:
2854 Habersham Road, Atlanta, GA 30305.
- b) No contract exists until the Company receives and acknowledges in writing a signed booking form with the relevant deposit payment.
- c) No additions, deletions, changes or promises may be made relating to these conditions, except in writing by a Director of the Company.

2. PAYMENT SCHEDULES

- a) A first deposit of US \$300 per person must be made with the booking form. Confirmation of your booking will then be sent by return mail.
- b) No later than 6 weeks after confirmation of your booking the Company must receive the second deposit of US \$300 per person.
- c) The final balance payment must be received by the Company no later than 12 weeks prior to departure.

3. PRICES

The Company reserves the right to impose surcharges in respect to cost increases related to fuel, or U.S. or foreign government action.

The Company will absorb increases equivalent to 2 percent of the trip price. If the surcharge exceeds 10 percent of the trip price, you have the right to cancel and receive a full refund of all monies paid.

4. CANCELLATION BY CUSTOMER

- a) Notification of cancellations must be made by requesting and submitting the official cancellation form by fax or mail.
- b) The 1st \$600 in deposits/payments are fully refundable until January 1, 2004, end of business. After this date the 1st \$600 in deposits are non refundable.
- c) The following scale of charges are payable by the customer for cancellations made later than Jan 1st end of business and after full balances have been paid:

84 to 15 days prior to departure: 60% of the total invoiced price

14 to 1 days prior to departure: 80% of the total invoiced price

Departure day or after date of travel: The total invoiced price

5. CANCELLATION BY THE COMPANY

- a) The Company reserves the right to cancel your trip. In the highly unlikely event of your trip being cancelled, you will have the choice of accepting an alternative arrangement or a full refund of the monies paid. The Company will ensure that any alternative arrangements offered are of at least equivalent standard to those originally booked.
- b) In no event will the Company cancel your trip less than 14 days prior to departure, except in the case of war, threat of war, political crisis, civil commotion or strife, terrorist activity, strikes or industrial action, natural disasters, fires, technical problems to transport, closure of airport or other circumstances beyond the Company's control.
